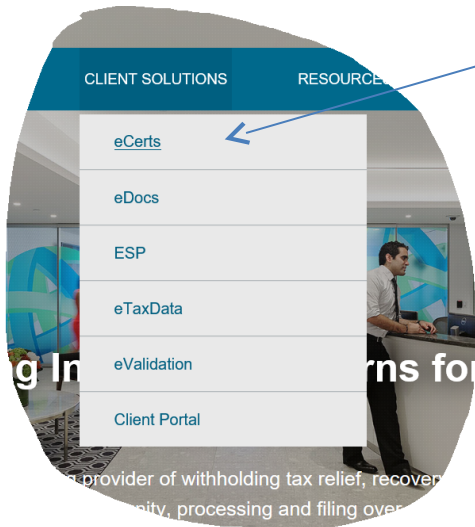


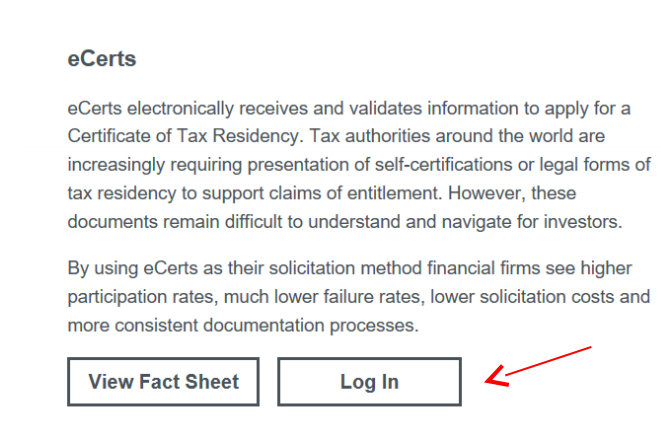

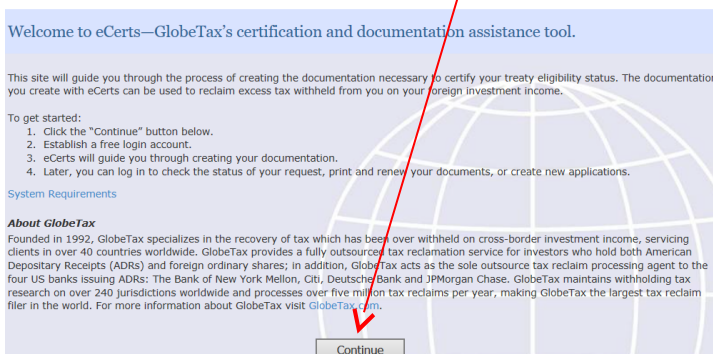

In March, you can register for exemption from the 20% Irish tax on your dividends. At that time, upon receipt of the email from GlobeTax, you must complete the form on the internet. They will then mail you

the form for your signature and return. There is a grace period that began August 17, 2016. However, by March 2017, there remains only approximately five months to get the proper documentation in place to avoid the 20% Irish tax on your dividends from Johnson Controls PLC.
