Several retirees have recently received a Johnson Controls Benefit Resources mailing. It references our Retiree Basic Life insurance policy. Some specify its death benefit as \$10,000 and some do not show any \$ figure. To the best of our knowledge everyone who has checked into it confirms that they still have a policy valued at \$10,000 death benefit. While we cannot say that this is consistent across all business units and all employment periods, it does appear that nothing has changed, and if you once had this benefit it is still there. ### **JCI Energy**

The section in the Journal Sentinel of 7/19/20 entitled "Power Source" with reference to the environment and corporate responsibility made me think about our Johnson Controls sustainable energy program. We ride down North Green Bay Ave and see the large array of the JCI solar panels at our Corporate Headquarters and wonder, how much power are they generating. We might also wonder how much electricity we are using at this site.

I took a look at the JCI website and found Fraser Ingerman, Director of JCI Global Media. Fraser referred me to Brian Pfeifer on the Facilities Team. Brian said that JCI's ground system is rated at 250KW and the roof array is 135KW. JCI used an average of 19,470,000 KWh of electricity per year in the last 10 years and produced an average of 400,000 KWh, about 2% of what we used. But, he said, we purchase renewal energy credits (RECs) from offsite services. So all the electrical energy used onsite is from renewable energy sources.

I went further into the JCI website to find global energy information on JCI. Johnson was the first US company to commit to the EP100 energy efficiency commitment. We endorse the Global Alliance for Energy Productivity with a goal of 3% energy efficiency per year. Also we are one of the Fortune 100 Companies in the Paris Business Commitment Agreement to align our operations and strategies to the UN Global Compact Principles. There are more details on JCI policies, COP22 Position Statement, Human Rights, etc. on the website.
